Port Waratah has a Diversity and Inclusion strategy which is a commitment to developing an increasingly diverse workforce and building a culture of fairness, equity and inclusiveness. The strategy is supported by our policy, along with initiatives and programs developed in consultation with employees lead by a Diversity and Inclusion Working Group (DIWG) established in 2016.

The DIWG have continued to initiate events and programs in support of a diverse culture, some specific initiatives aimed at improving gender equality in the 2017-2018 reporting period, were:

- Arranging unconscious bias training sessions in 2017, of which 72% of employees attended
- Adding Specialist Hotlines as an offering under our current Employee Assistance Program. The Specialist Hotline offer counselling, referral and support services for Aboriginal and Torres Strait Islander Peoples, LGBTIQ Peoples and people experiencing Family and Domestic Violence.

Port Waratah takes very seriously the issue of Domestic Violence for both our employees and our local community. As in previous years, Port Waratah continued in 2017/2018 to provide financial contribution to a local Newcastle Domestic Violence Resource Centre called "Jenny's Place", with the aim of assisting women and children who are in crisis because of being exposed to the damaging effects of violence in their homes and/or who are homeless or at risk of being homeless. Our commitment to "Jenny's Place" however, is more than financial, we have also committed to a two-year partnership offering support services wherever we are able. In June 2017 our HR team partnered with the Jenny's Place Management and Board to provide specialised HR support and tools throughout the recruitment process of their Corporate Sponsorship Officer. We are pleased that our support resulted in the successful appointment of this role.

Port Waratah consistently attracted reasonably large and strong fields of candidates for employment vacancies across the year. "Your career at Port Waratah can be diverse!" was an internal recruitment campaign that attracted an increase in applications, particularly from our current employees and their development opportunities at Port Waratah.

In 2017-2018, four (4) female employees accepted temporary secondment opportunities, of which three (3) of these secondment opportunities allowed the employees to move outside the scope of their original role and department, into the Service Assurance (Operations) Department to develop and enhance a more technical skill-set. Two (2) of these secondments have resulted in a permanent offer and promotion into a higher level role. One (1) of the temporary secondments was performing higher duties in a leadership role

To attract more female applicants outside of our organisation, we re-worked our advertising templates to have a stronger focus on the females in our workplace and to include key diversity messaging. As a result, we successfully recruited a female operator which increased our female operators from 2 to 3.

The percentage of vacant roles filled externally by females was 52% in the 2017/2018 reporting period, which is up from 33% in the 2016/2017 reporting period.

A diversity/gender milestone occurred with two females joining the Port Waratah Executive team in 2017 - Manager Human Resources and Manager Environment and Community Relations- increasing the female participation at Executive level from 0% to 40%.

Port Waratah continues to support the Newcastle University Scholarship Program, which provides financial support to 2 new university students every year, plus the offer of up to 10 weeks paid summer vacation work placements.

In 2017-2018, Port Waratah supported four (4) female and three (3) male scholarship students through paid work experience in addition to their annual bursary.

Port Waratah continues to support the Women In Mining (WIMnet) mentoring program which is only face-to-face mentoring program for women working in the NSW resources sector. The program matches mentees and mentors with the help of Registered Psychologists, and conducts career guidance training and workshops. In 2017, we supported two (2) female employees and in 2018 we are supporting and four (4) female employees participating in the program.

In 2017-2018, three (3) female employees were promoted into Management roles, 2 of which were prior participants of the WIMnet mentoring program and 1 is participating in the 2018 program.

In 2017-2018, Five (5) or 16% of our female staff employees are on either a Flexible Working Arrangement (FWA) or working in part-time capacity, to support their family commitments. In addition, during the 2017-2018 period one (1) male employee applied and was approved for an FWA to support family commitments during the next reporting period.

One (1) or 33% of our female Enterprise Agreement (EA) employee continues to utilise an Individual Flexibility Arrangement to support her family commitments.
